# 2011 Eugene Pro Rodeo

## COWHIDE RACE - \$500 Added Money!!

\$10 Entry Fee per run. All fees will go into a jackpot. Team with the best time after 3 days wins the pot! Must be 16 years of age or older to participate and all riders under 18 must wear standard helmets with chin strap. Cowhide Race will be done each night during the pre-rodeo show July 1-4, 2011.

Teams may enter more than once, swap horse and hide riders, just \$10 each run. We'll do our best to accommodate your preferred run dates.

There will be two contestants to each team. A hide of at least 6 sq. feet is used. Hide is attached to a rope not to exceed 30 feet in length, which shall be dallied (no hard, fast tie permitted) to the horn of the saddle. We'll supply the hide and the rope.

Horse and rider must drag hide the length of the course and over the hide line at the far end of the 120 foot course. Horse must have all four feet over the line. Rider must be in control of horse at all times. Teammate rides hide back over finish line, which is also the starting line. There will be a 5 second penalty for knocking over a barrel or pole and disqualification for going off course.

**Teammate riding the hide must be stationed on the hide and must be prone, sitting or kneeling (NOT STANDING) on the hide as he crosses the start/finish line.** He is not required to maintain continuous contact with the hide throughout the entire race nor be on top of the hide, but must be pulled completely across the finish line. Hide rider may wear coveralls, headgear, and footwear other than western.

Eugene Pro Rodeo is given the unconditional and absolute right to settle or compromise any such claim.

I/We further agree, for ourself(ves) and on behalf of Cow Hide Racer:

1. Assumption of Risk. I/We know and understand the scope, nature, and extent of the risks involved in cow hide races and related activities contemplated by this Agreement and voluntarily and freely choose to incur such risks on behalf of Cow Hide Racer understanding those risks may include INJURY or DEATH. I/We acknowledge that the activities contemplated by this Agreement are inherently dangerous in nature. ( ) Initial(s)
  
2. Covenant Not to Sue. I/We agree never to institute any suit or action at law or otherwise and hereby instruct my/our heirs, executors and administrators never to institute any suit or action at law or otherwise against Eugene Pro Rodeo nor to initiate any nor assist the prosecution of any claim for damages or cause of action which I/we may have by reason of INJURY or DEATH to our Cow Hide Racer's person or property arising from the activities contemplated by this Agreement.

- 3 Exemption from Liability. I/We exempt and release Eugene Pro Rodeo from any and all liability, claims, demands or actions or causes of action whatsoever arising out of any damage, loss, INJURY or DEATH to Cow Hide Racer or Cow Hide Racer's property while upon the premises or while participating in any of the activities contemplated by the Agreement, whether such loss, damage, INJURY or DEATH results from the negligence, either ACTIVE or PASSIVE, of Eugene Pro Rodeo or some other cause. I agree that the owners and operators of this event have no responsibility for the acts or safety of Cow Hide Racer. I/We understand that I/We are giving up legal rights which I/We or Cow Hide Racer may otherwise have by entering into this Agreement. (            ) Initial(s)
- 4 Validity of Waiver.
